Summary (as of Apr 13, 2023)

Working Families Task Force Act of 2023

This bill requires the Department of Labor to establish an interagency task force to report on, and make recommendations for improving, the standard of living and quality of life for working families. Labor must consult with specified departments, including the Departments of Agriculture, Commerce, and Transportation, on the task force.

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Work and Welfare.
- **Apr 13, 2023:** Introduced in House
- **Apr 13, 2023:** Referred to the Committee on Education and the Workforce, and in addition to the Committees on Financial Services, Ways and Means, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
