Summary (as of Apr 13, 2023)

Permit Reform In Mining for Energy and Defense Act or the PRIMED Act

This bill makes certain actions taken by the Department of Defense to secure critical materials for energy infrastructure (e.g., minerals) eligible for an expedited environmental review by including those projects within the scope of *covered projects* under the Fixing America's Surface Transportation (FAST) Act.

Actions Timeline

- **May 22, 2023:** Referred to the Subcommittee on Energy and Mineral Resources.
- **Apr 13, 2023:** Introduced in House
- **Apr 13, 2023:** Referred to the House Committee on Natural Resources.
