Hershel "Woody" Williams National Medal of Honor Monument Location Act

This bill requires the authorized commemorative work honoring Medal of Honor recipients to be located within the Reserve (the great cross-axis of the National Mall, which generally extends from the Capitol to the Lincoln Memorial and from the White House to the Jefferson Memorial).

- **Nov 8, 2023:** Passed/agreed to in House: On motion to suspend the rules and pass the bill, as amended Agreed to by voice vote. (text: 11/6/2023 CR H5416)
- **Nov 8, 2023:** On motion to suspend the rules and pass the bill, as amended Agreed to by voice vote. (text: 11/6/2023 CR H5416)
- **Nov 8, 2023:** Motion to reconsider laid on the table Agreed to without objection.
- **Nov 6, 2023:** Mr. Westerman moved to suspend the rules and pass the bill, as amended.

- **Nov 6, 2023:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Westerman objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was considered as withdrawn.
