## Summary (as of Jan 11, 2023)

This resolution condemns the Supreme Court's holding in *Dobbs v. Jackson Women's Health Organization* (that there is no constitutional right to abortion) and expresses a commitment to instituting judicial reform and supporting access to abortion and the communities affected by the Court's ruling. It also urges the executive branch to advance reproductive justice.

## Actions Timeline

- **Jan 20, 2023:** Referred to the Subcommittee on Health.
- **Jan 11, 2023:** Introduced in House
- **Jan 11, 2023:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
