Summary (as of Apr 13, 2023)

Encouraging the European Union to Determine that the European Union Should Sanction the Iranian Revolutionary Guard Corps Now As a Terrorist Entity Resolution or Encouraging the EU to DESIGNATE Resolution

This resolution urges the European Union (EU) to expeditiously designate the Islamic Revolutionary Guard Corps (IRGC) as a terrorist organization under the EU Common Position 931 on terrorism. It also encourages the Biden Administration to make the EU designation of the IRGC as a terrorist organization a diplomatic priority in engagements with the EU.

Actions Timeline

- **Apr 16, 2024:** Mr. Wilson (SC) moved to suspend the rules and agree to the resolution.
- **Apr 16, 2024:** Considered under suspension of the rules. (consideration: CR H2428-2430)
- **Apr 16, 2024:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 288.
- **Apr 16, 2024:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
