#### **Strengthen and Tackle Opportunities to Prevent Violence Act of 2023 or the STOP Violence Act of 2023**

This bill allows funds under the Edward Byrne Memorial Justice Assistance Grant Program to be used to assist public assembly facilities in preparing for and protecting against mass violence.
