## Summary (as of Apr 28, 2023)

### North Korean Human Rights Reauthorization Act of 2023

This bill reauthorizes through FY2028 various activities to promote human rights in North Korea. These activities include (1) providing grants to nonprofit organizations to promote human rights, democracy, rule of law, and the development of a market economy in North Korea; (2) increasing the availability of sources of information inside North Korea that are not controlled by North Korea's government; and (3) supporting organizations that provide humanitarian assistance to North Koreans who are outside of North Korea without the permission of North Korea's government.

## Actions Timeline

- **Nov 21, 2024:** Received in the Senate and Read twice and referred to the Committee on Foreign Relations.
- **Nov 20, 2024:** Mr. Moylan moved to suspend the rules and pass the bill, as amended.
- **Nov 20, 2024:** Considered under suspension of the rules. (consideration: CR H6121-6123)
- **Nov 20, 2024:** DEBATE - The House proceeded with forty minutes of debate on H.R. 3012.
- **Nov 20, 2024:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
