Military Housing Transparency and Accountability Act

This bill modifies requirements for the complaint database for military housing that the Department of Defense must establish. The bill specifies that complaints may be made by a member of the Armed Forces or dependent that resides in a covered dwelling unit (i.e., a unit of accompanied family housing, unaccompanied housing, or barracks in which a member resides but does not own).

The Office of the Assistant Secretary of Defense for Energy, Installations, and Environment must annually report to Congress with a summary of the data collected by the complaint database and any actions taken to remedy complaints.

- **May 9, 2023:** Referred to the House Committee on Armed Services.
