Summary (as of May 15, 2023)

Improving Diaper Affordability Act of 2023

This bill treats diapers as qualified medical expenses for purposes of health savings accounts, health reimbursement arrangements, and other types of health spending arrangements.

The bill also prohibits a state or local government from imposing a sales tax on the retail sale of diapers.

Actions Timeline

- Dec 17, 2024: Referred to the Subcommittee on Health.
- May 15, 2023: Introduced in House
- May 15, 2023: Referred to the Committee on Ways and Means, and in addition to the Committee on the Judiciary, for a
 period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within
 the jurisdiction of the committee concerned.
