Summary (as of May 16, 2023)

Colorectal Cancer Payment Fairness Act

This bill eliminates Medicare coinsurance requirements with respect to colorectal cancer screening tests, regardless of the code billed for a resulting diagnosis or procedure, beginning in 2023 (rather than 2030).

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Health.
- **May 19, 2023:** Referred to the Subcommittee on Health.
- **May 16, 2023:** Introduced in House
- **May 16, 2023:** Sponsor introductory remarks on measure. (CR H2373)
- **May 16, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
