Summary (as of May 22, 2023)

Secure Testing Resources Instead of Prosecuting Act or the STRIP Act

This bill exempts the possession, sale, or purchase of fentanyl drug testing equipment, including test strips, from criminal penalties under the Controlled Substances Act.

Actions Timeline

- **May 26, 2023:** Referred to the Subcommittee on Health.
- **May 22, 2023:** Introduced in House
- **May 22, 2023:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
