Promoting United States Leadership in Standards Act of 2024

This bill requires the National Institute of Standards and Technology (NIST) to support U.S. involvement in the development of standards for artificial intelligence (AI) through briefings, pilot programs, and other activities.

Specifically, NIST must (1) brief Congress on opportunities for the federal government to participate in the process for developing technical standards for AI, (2) establish a web portal to inform U.S. industries and federal agencies of international efforts and opportunities to develop such standards, and (3) establish a pilot program and award associated grants to support stakeholder meetings in the U.S. on developing such standards.

Actions Timeline

- **Aug 1, 2024:** Committee on Commerce, Science, and Transportation. Reported by Senator Cantwell with an amendment in the nature of a substitute. Without written report.
- **Aug 1, 2024:** Placed on Senate Legislative Calendar under General Orders. Calendar No. 482.
- **Jul 31, 2024:** Committee on Commerce, Science, and Transportation. Ordered to be reported with an amendment in the nature of a substitute favorably.
- **Feb 29, 2024:** Introduced in Senate
- **Feb 29, 2024:** Read twice and referred to the Committee on Commerce, Science, and Transportation.
