## Expanded Telehealth Access Act

This bill expands the types of health care practitioners who may provide telehealth services under Medicare.

Specifically, the bill permanently allows audiologists, physical therapists, occupational therapists, speech-language pathologists, and other providers designated by the Centers for Medicare & Medicaid Services to provide telehealth services under Medicare. It also specifically allows occupational therapy assistants and physical therapist assistants to provide such services.

- **Jun 9, 2023:** Referred to the Subcommittee on Health.
- **Jun 6, 2023:** Introduced in House
- **Jun 6, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
