Quiet Communities Act of 2023

This bill requires the Environmental Protection Agency to reestablish an Office of Noise Abatement and Control to promote the development of local noise control programs and carry out related duties.

Actions Timeline

- **Jun 16, 2023:** Referred to the Subcommittee on Environment, Manufacturing, and Critical Materials.
- **Jun 15, 2023:** Introduced in House
- **Jun 15, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 15, 2023:** Referred to the Subcommittee on Aviation.
- **Jun 15, 2023:** Referred to the Subcommittee on Highways and Transit.
- **Jun 15, 2023:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
