## **Amputation Reduction and Compassion Act of 2023 or the ARC Act of 2023**

This bill provides for coverage of peripheral artery disease screening tests without cost-sharing under Medicare and Medicaid for certain at-risk individuals. It also requires the development of certain educational programs, a payment model, and Medicare quality measures to reduce amputations relating to such disease.

### **Actions Timeline**

---

- **Dec 17, 2024:** Referred to the Subcommittee on Health.
- **Dec 3, 2024:** ASSUMING FIRST SPONSORSHIP - Mr. Jackson (IL) asked unanimous consent that he may hereafter be considered as the first sponsor of H.R. 4261, a bill originally introduced by Representative Payne, for the purpose of adding cosponsors and requesting reprintings pursuant to clause 7 of rule XII. Agreed to without objection.
- **Jun 23, 2023:** Sponsor introductory remarks on measure. (CR H3129)
- **Jun 23, 2023:** Referred to the Subcommittee on Health.
- **Jun 21, 2023:** Introduced in House
- **Jun 21, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
