No Funds for Armed Regulators Act of 2023

This bill prohibits federal funds from being expended on the hiring or retention of an armed regulatory enforcement officer for the Internal Revenue Service, the Department of Labor, or the Environmental Protection Agency.

Actions Timeline

- **Aug 28, 2023:** Referred to the Subcommittee on Conservation, Research, and Biotechnology.
- **Jul 7, 2023:** Referred to the Subcommittee on Environment, Manufacturing, and Critical Materials.
- **Jul 3, 2023:** Referred to the Subcommittee on Water Resources and Environment.
- **Jun 30, 2023:** Introduced in House
- **Jun 30, 2023:** Referred to the Committee on Ways and Means, and in addition to the Committees on Education and the Workforce, Energy and Commerce, Transportation and Infrastructure, and Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
