#### Providing Opportunities to Show Transparency via Information Technology Act of 2023 or the POST IT Act of 2023

This bill requires the Small Business Administration's Office of the National Ombudsman to include hyperlinks on its website to any guidance that sets forth policy related to a rule covered by a small entity compliance guide.
