## **Department of the Interior, Environment, and Related Agencies Appropriations Act, 2024**

This bill provides FY2024 appropriations for the Department of the Interior, the Environmental Protection Agency (EPA), and several related agencies.

The bill provides appropriations to Interior for

- the Bureau of Indian Affairs,
- the Bureau of Indian Education,
- the Bureau of Trust Funds Administration,
- Departmental Offices, and
- Department-Wide Programs.

The bill also provides appropriations to the EPA and the Forest Service.

Within the Department of Health and Human Services, the bill provides appropriations for

- the Indian Health Service,
- the National Institute of Environmental Health Sciences, and
- the Agency for Toxic Substances and Disease Registry.

The bill provides appropriations to several related agencies, including

- the Council on Environmental Quality and Office of Environmental Quality,
- the Chemical Safety and Hazard Investigation Board,
- the Office of Navajo and Hopi Indian Relocation,
- the Institute of American Indian and Alaska Native Culture and Arts Development,
- the Smithsonian Institution,

- the National Endowment for the Arts,
- the National Endowment for the Humanities,

Additionally, the bill sets forth requirements and restrictions for using funds provided by this and other appropriations acts.
