Enabling More of the Physical and Occupational Workforce to Engage in Rehabilitation Act or the EMPOWER Act

This bill prohibits the supervision requirements for physical therapy assistants and occupational therapy assistants for covered outpatient services under Medicare from being different from supervision requirements under state law. The Government Accountability Office must report on the impact of Medicare payment differentials for such services in rural areas.

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Health.
- **Jul 28, 2023:** Referred to the Subcommittee on Health.
- **Jul 25, 2023:** Introduced in House
- **Jul 25, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
