Summary (as of Jun 13, 2023)

This resolution impeaches President Biden for high crimes and misdemeanors relating to actions taken involving immigration and the southern border.

Actions Timeline

- **Aug 23, 2023:** Referred to the Subcommittee on Oversight, Investigations, and Accountability.
- **Aug 23, 2023:** Referred to the Subcommittee on Border Security and Enforcement.
- **Jun 22, 2023:** Rereferred to the Committee on Homeland Security, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 20, 2023:** NOTIFICATION OF INTENT TO OFFER RESOLUTION - Mrs. Boebert notified the House of her intent to offer a privileged resolution pursuant to clause 2(a)(1) of rule IX. The Chair announced that a determination will be made at the time designated for consideration of the resolution.
- **Jun 13, 2023:** Introduced in House
