This resolution censures Representative Adam Schiff for conduct that misleads the American people and directs the Committee on Ethics to investigate that conduct.

## Actions Timeline

- **Jun 21, 2023:** QUESTION OF THE PRIVILEGES OF THE HOUSE - Mrs. Luna rose to a question of the privileges of the House and offered the resolution. The Chair directed the Clerk to report the resolution. Upon examination of the resolution, the Chair determined that the resolution did constitute a question of the privileges of the House.
- **Jun 21, 2023:** Considered as privileged matter. (consideration: CR H3013-3021)
- **Jun 21, 2023:** Ms. Clark (MA) moved to table the measure.
- **Jun 21, 2023:** On motion to table the measure Failed by recorded vote: 208 - 218 (Roll no. 276).
- **Jun 21, 2023:** DEBATE - The House proceeded with one hour of debate on H. Res. 521.
- **Jun 21, 2023:** The previous question was ordered without objection.
- **Jun 21, 2023:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 521, the Chair put the question on agreeing to the resolution and by voice vote, announced the ayes had prevailed. Mr. Raskin demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Jun 21, 2023:** Considered as unfinished business. (consideration: CR H3048)
- **Jun 21, 2023:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 213 - 209, 6 Present (Roll no. 283). (text: CR H3013)
