

## HRES 524

Providing for consideration of the bill (H.R. 3564) to cancel recent changes made by the Federal Housing Finance Agency to the up-front loan level pricing adjustments charged by Fannie Mae and Freddie Mac for guarantee of single-family mortgages, and for other purposes; providing for consideration of the bill (H.R. 3799) to amend the Internal Revenue Code of 1986 to provide for health reimbursement arrangements integrated with individual health insurance coverage; and providing for consideration of the resolution (H. Res. 461) condemning the use of elementary and secondary school facilities to provide shelter for aliens who are not admitted to the United States.

This resolution sets forth the rule for consideration of

- H.R. 3564 (Middle Class Borrower Protection Act of 2023, which rolls back changes made by the Federal Housing Finance Agency to certain fees, namely loan-level pricing adjustments, charged by Fannie Mae and Freddie Mac for a conventional single-family mortgage and restricts future fee adjustments),
- H.R. 3799 (Custom Health Option and Individual Care Expense Arrangement Act or the CHOICE Arrangement Act, which provides statutory authority for regulations that allow employers to offer individual coverage health reimbursement arrangements), and
- H. Res. 461 (which condemns using the facilities of a public elementary or secondary school that serves students to provide shelter for non-U.S. nationals who are not admitted into the United States).

## **Actions Timeline**

- **Jun 21, 2023:** Considered as privileged matter. (consideration: CR H3003-3011)
- **Jun 21, 2023:** DEBATE - The House proceeded with one hour of debate on H. Res. 524.
- **Jun 21, 2023:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 524, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Jun 21, 2023:** Considered as unfinished business. (consideration: CR H3011-3013)
- **Jun 21, 2023:** On ordering the previous question Agreed to by the Yeas and Nays: 215 - 207 (Roll no. 274).

- **Jun 20, 2023:** The resolution provides for consideration of H.R. 3564 under a structured rule with one hour of general debate; H.R. 3799 under a structured rule with eighty minutes of general debate; and H.Res. 461, under a closed rule with one hour of general debate. The resolution provides for a motion to recommit on H.R. 3564 and H.R. 3799.
