Summary (as of Jun 22, 2023)

This resolution refers H. Res. 503 from the House floor to the Committee on Homeland Security and the Committee on the Judiciary. That resolution impeaches President Joe Biden for high crimes and misdemeanors relating to actions taken that involve immigration and the southern border.

Actions Timeline

- **Jun 22, 2023:** Considered as privileged matter. (consideration: CR H3077-3087)
- **Jun 22, 2023:** DEBATE - The House proceeded with one hour of debate on H. Res. 529.
- **Jun 22, 2023:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 529, the Chair put the question on ordering the previous question, and by voice vote announced the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.

- **Jun 22, 2023:** On ordering the previous question Agreed to by the Yeas and Nays: 214 - 206 (Roll no. 284).
