### Summary (as of Jan 26, 2023)

---

This bill prohibits China, Iran, North Korea, or Russia from purchasing property within 10 miles of a sensitive site, such as a U.S. military installation. The prohibition also applies to leases or receiving concessions to property within 10 miles of a sensitive site.

For the purposes of this bill, a sensitive site is public or private real estate in the United States that (1) functions as an air or maritime port, (2) is a U.S. military installation, (3) is a U.S. government facility that is sensitive for national security reasons, or (4) could expose U.S. national security activities or intelligence at a military installation or government facility to one of the prohibited countries.

The prohibition shall apply to purchases, leases, and concessions made on or after this bill's enactment.

### Actions Timeline

---

- **Feb 3, 2023:** Referred to the Subcommittee on Innovation, Data, and Commerce.
- **Jan 26, 2023:** Introduced in House
- **Jan 26, 2023:** Referred to the Committee on Financial Services, and in addition to the Committees on Foreign Affairs, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
