Summary (as of Jul 13, 2023)

This resolution sets forth the rule for further consideration of H.R. 2670 (National Defense Authorization Act for Fiscal Year 2024, which authorizes appropriations and sets forth policies for Department of Defense programs and activities; military construction; the national security programs of the Department of Energy; the Maritime Administration; the Defense Nuclear Safety Board; and the Naval Petroleum Reserves).

Actions Timeline

- **Jul 13, 2023:** Introduced in House
- **Jul 13, 2023:** The House Committee on Rules reported an original measure, H. Rept. 118-142, by Mr. Cole.
- **Jul 13, 2023:** The resolution provides for further consideration of H. R. 2670 under a structured rule. The resolution makes in order only those further amendments printed in House Report 118-142. One motion to recommit provided.
- **Jul 13, 2023:** Placed on the House Calendar, Calendar No. 29.
- **Jul 13, 2023:** Considered as privileged matter. (consideration: CR H3495-3501)
- **Jul 13, 2023:** DEBATE - The House proceeded with one hour of debate on H. Res. 583.
- **Jul 13, 2023:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 583, the Chair put the question on ordering the previous question and by voice announced the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Jul 13, 2023:** Considered as unfinished business. (consideration: CR H3501-3503)
- **Jul 13, 2023:** On ordering the previous question Agreed to by the Yeas and Nays: 214 - 207 (Roll no. 295).
