Freezing and Halting Any More Alleviation of Sanctions Act or Freezing HAMAS Act

This bill reinstates any statutory sanctions against Iran that had been waived, reduced, or otherwise relieved pursuant to any agreement between the United States and Iran.

- **Nov 14, 2023:** Committee Consideration and Mark-up Session Held
- **Nov 14, 2023:** Ordered to be Reported in the Nature of a Substitute (Amended) by the Yeas and Nays: 37 - 13.
- **Oct 25, 2023:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on Financial Services, Oversight and Accountability, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
