Summary (as of Oct 17, 2023)

Keeping Drugs Out of Schools Act of 2023

This bill allows the Office of National Drug Control Policy to award grants for eligible entities to implement school-community partnerships for preventing and reducing substance use and misuse among youth. *Eligible entity* refers to a coalition that (1) is a Drug-Free Communities funded coalition on or before the date on which the coalition submits a grant application, and (2) has a memorandum of understanding in effect with not less than one local school to establish a school-community partnership.

- **Oct 25, 2023:** Referred to the House Committee on Energy and Commerce.
- **Oct 17, 2023:** Introduced in House
