### Summary (as of Nov 15, 2023)

#### Ending Importation of Laundered Russian Oil Act

This bill prohibits the importation of energy products that were produced at any refinery that uses crude oil originating in Russia.

Current law prohibits the importation of Russian products that are classified under chapter 27 of the Harmonized Tariff Schedule (which includes mineral fuels, mineral oils and products of their distillation, bituminous substances, and mineral waxes). The bill extends this prohibition to products that were produced at any refinery that uses crude oil originating in Russia.

## **Actions Timeline**

---

- **Dec 17, 2024:** Referred to the Subcommittee on Trade.
- **Nov 15, 2023:** Introduced in House
- **Nov 15, 2023:** Referred to the Committee on Ways and Means, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
