### Chinese Spy Balloon Assessment Act

This bill requires the Department of Defense to consult with the President and report on the effects on national security of surveillance conducted by China via the high-altitude surveillance balloon shot down in the United States in February 2023. The report must be submitted in an unclassified form, but may include a classified annex.
