Summary (as of Dec 7, 2023)

Preserving Seniors' Access to Physicians Act of 2023

This bill increases payments under the Medicare physician fee schedule for 2024. Specifically, the bill increases payments for 2024 by 4.62% (current law provides for a 1.25% increase).

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Health.
- **Dec 8, 2023:** Referred to the Subcommittee on Health.
- **Dec 7, 2023:** Introduced in House
- **Dec 7, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
