Debt-to-GDP Transparency and Stabilization Act

This bill requires the President's annual budget and congressional budget resolutions to include the ratio of the public debt to the estimated gross domestic product.

- **Jan 11, 2024:** Referred to the Committee on the Budget, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
