Summary (as of Feb 1, 2023)

Fair COLA for Seniors Act of 2023

This bill bases cost-of-living adjustments for certain benefits available through federal and military retirement programs, Social Security, and specified programs for veterans on a price index that tracks the spending patterns of older consumers. The Bureau of Labor Statistics of the Department of Labor must publish that price index on a monthly basis.

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Social Security.
- **Feb 28, 2023:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Feb 1, 2023:** Introduced in House
- **Feb 1, 2023:** Sponsor introductory remarks on measure. (CR E81)
- **Feb 1, 2023:** Referred to the Committee on Ways and Means, and in addition to the Committees on Veterans' Affairs, Oversight and Accountability, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
