HUD Transparency Act of 2024

This bill requires the Office of Inspector General of the Department of Housing and Urban Development (HUD) to annually testify before Congress.

Specifically, the office must testify regarding

- efforts to detect and prevent fraud, waste, and abuse;
- ability to conduct and supervise audits, investigations, and reviews;
- actions to identify opportunities for HUD programs to progress and succeed;
- recommendations to improve overall efficiency and public accountability;
- the extent to which HUD has resources sufficient to carry out its statutory mission; and
- ongoing activities regarding any such additional work.

- **Jul 23, 2024:** Received in the Senate and Read twice and referred to the Committee on Banking, Housing, and Urban Affairs.
- **Jul 22, 2024:** Mr. Nunn (IA) moved to suspend the rules and pass the bill, as amended.
- **Jul 22, 2024:** Considered under suspension of the rules. (consideration: CR H4653-4654)
- **Jul 22, 2024:** DEBATE - The House proceeded with forty minutes of debate on H.R. 7280.
