Save Medicare Act

This bill renames Medicare Advantage (MA) as the Alternative Private Health Plan program. It also establishes civil penalties for entities that continue to advertise MA plans with *Medicare* in the title.

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Health.
- **Feb 10, 2023:** Referred to the Subcommittee on Health.
- **Feb 1, 2023:** Introduced in House
- **Feb 1, 2023:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
