No Capital Gains Allowance for American Adversaries Act

This bill treats gains and dividends derived from transactions involving countries of concern as ordinary income. The bill defines *countries of concern* to include China (including Hong Kong and Macao and excluding Taiwan), Russia, Belarus, Iran, and North Korea.
