Actions Timeline

- **Nov 3, 2023:** Referred to the Subcommittee on Health.
- **Oct 25, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Armed Services, and Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Oct 24, 2023:** Introduced in House
