## Actions Timeline

- **Feb 1, 2023:** Introduced in House
- **Feb 1, 2023:** The House Committee on Rules reported an original measure, H. Rept. 118-2, by Mr. Reschenthaler.
- **Feb 1, 2023:** All points of order against consideration and provisions are waived and are considered as read. Rule also provides for one hour of general debate on each resolution.
- **Feb 1, 2023:** Placed on the House Calendar, Calendar No. 2.
- **Feb 1, 2023:** Considered as privileged matter. (consideration: CR H590-598)
- **Feb 1, 2023:** DEBATE - The House proceeded with one hour of debate on H. Res. 83.
- **Feb 1, 2023:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 83, the Chair put the question on ordering the previous question on H. Res. 83 and by voice vote, announced that the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Feb 1, 2023:** Considered as unfinished business. (consideration: CR H598-599)
- **Feb 1, 2023:** On ordering the previous question Agreed to by the Yeas and Nays: 219 - 207 (Roll no. 101).
- **Feb 1, 2023:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 218 - 209 (Roll no. 102). (text: CR H590)
- **Feb 1, 2023:** On agreeing to the resolution Agreed to by recorded vote: 218 - 209 (Roll no. 102). (text: CR H590)
