This concurrent resolution denounces socialism and opposes the implementation of socialist policies in the United States.

Actions Timeline

- **Feb 2, 2023:** Considered under the provisions of rule H. Res. 83. (consideration: CR H635-643)
- **Feb 2, 2023:** Rule provides for consideration of H. Con. Res. 9 and H. Res. 76. All points of order against consideration and provisions are waived and are considered as read. Rule also provides for one hour of general debate on each resolution.
- **Feb 2, 2023:** DEBATE - The House proceeded with one hour of debate on H. Con. Res. 9.
- **Feb 2, 2023:** The previous question was ordered pursuant to the rule on the resolution and the preamble.
- **Feb 2, 2023:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Con Res. 9, the Chair put the question on agreeing to the resolution and by voice vote, announced that the ayes had prevailed. Mr. McHenry demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
