Summary (as of Jul 25, 2024)

Accelerating the Development of Advanced Psychology Trainees Act or the ADAPT Act

This bill provides for Medicare coverage of services that are furnished by advanced psychology trainees. It also requires the Centers for Medicare & Medicaid Services to issue guidance for states on coverage options for such services under Medicaid and the Children's Health Insurance Program (CHIP).

Actions Timeline

- **Dec 17, 2024:** Referred to the Subcommittee on Health.
- **Jul 25, 2024:** Introduced in House
- **Jul 25, 2024:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
