Further, it provides for consideration of the joint resolution (H.J. Res. 98) providing for congressional disapproval of the rule submitted by the National Labor Relations Board titled *Standard for Determining Joint Employer Status*.

Finally, it provides for consideration of the joint resolution (S.J. Res. 38) providing for congressional disapproval of the rule submitted by the Federal Highway Administration titled *Waiver of Buy America Requirements for Electric Vehicle Chargers*.

Res. 38 under a closed rule, with one hour of general debate on each joint resolution. Also, the resolution provides for a motion to recommit on H.R. 788 and H.J. Res. 98. A motion to commit on S.J. Res. 38.
