This bill reauthorizes through FY2031 the Office of National Drug Control Policy and related grants, programs, and initiatives such as

- the High Intensity Drug Trafficking Areas program,
- the Drug-Free Communities program,
- the Drug Court Training and Technical Assistance program, and
- the National Community Anti-Drug Coalition Institute.
