### COVID-19 Vaccination Non-Discrimination Act

This bill prohibits making federal funds available to any facility that refuses to treat an individual based on the individual's COVID-19 vaccination status, including any funding under Medicare, Medicaid, or the Children's Health Insurance Program (CHIP).

### Actions Timeline

---

- **Feb 24, 2023:** Referred to the Subcommittee on Health.
- **Feb 14, 2023:** Introduced in House
- **Feb 14, 2023:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
