119 HR 2510	Related bill	Mar 31, 2025: Referred to the Committee on Foreign Affairs, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

This bill eliminates certain statutory restrictions on U.S. security assistance to Cyprus, Greece, and Turkey.

For example, the bill eliminates requirements that the President

- as a condition of transferring defense articles to Cyprus, annually certify to Congress that Cyprus is taking certain
  actions with regards to money laundering, financial regulatory oversight, and denying refueling and servicing to
  Russian military vessels; and
- when requesting certain security assistance funds from Congress for Greece and Turkey, certify that providing such assistance is compatible with specified principles that support U.S. policy in the region (e.g., that such security assistance is intended solely for defensive purposes and preserves the balance of military strength among countries of the region).
