This bill increases the monthly special pension for living Medal of Honor recipients from \$1,406.73 to \$8,333.33 and establishes a rate of \$1,406.73 for the monthly special pension for surviving spouses of Medal of Honor recipients. Both amounts must be adjusted annually for inflation.
