Biography

A Senator from New Hampshire. Born in Nashua, N. H. , June 27, 1968. Graduated Pennsylvania State University, B. A. , 1990. Graduated Villanova University, J. D. , 1993. Law clerk to New Hampshire Supreme Court Justice Sherman Horton. Lawyer. Prosecutor, New Hampshire attorney general's office 1998-2000. Staff, New Hampshire attorney general 2000-2003. Counsel to New Hampshire Governor Craig Benson 2003. Deputy attorney general of New Hampshire 2003-2004. Attorney general of New Hampshire 2004-2009. Elected as a Republican to the United States Senate in 2010, and served from January 3, 2011, to January 3, 2017. Was an unsuccessful candidate for re-election to the Senate in 2016. Elected governor of New Hampshire in 2024, and took the oath of office on January 9, 2025.
