United States Air Force, 1950-1954. Steelworker. Engineer. College instructor. Lawyer, private practice. Municipal judge, city of Tarpon Springs, Fla. , and city of New Port Richey, Fla. Elected as a Republican to the Ninety-eighth and to the eleven succeeding Congresses (January 3, 1983-January 3, 2007). Not a candidate for reelection to the One Hundred Tenth Congress in 2006.
