Member of the North Dakota state house of representatives, 1984-2010. Speaker, North Dakota state house of representatives, 1993. Majority leader, North Dakota state house of representatives, 2003-2009. Elected as a Republican to the One Hundred Twelfth Congress (January 3, 2011-January 3, 2013). Not a candidate for reelection in 2012, but was an unsuccessful candidate for the United States Senate. Chair, North Dakota Republican Party, 2018-2020.
