A Representative from California. Born in Los Angeles, Los Angeles County, Calif. , December 8, 1941. B. A. , University of Missouri, Columbia, Mo. , 1964. M. A. , University of Missouri, Columbia, Mo. , 1965. M. B. A. , National University, San Diego, Calif. , 1985. United States Navy, 1966-1987. Teacher. Lecturer. Businessman. Elected as a Republican to the One Hundred Second and to the seven succeeding Congresses until his resignation on December 1, 2005 (January 3, 1991-December 1, 2005). Convicted on March 3, 2006, of tax evasion and conspiracy. Conditional pardon granted by President Donald J. Trump on January 13, 2021. Died on August 27, 2025, in Little Rock, Ark.
