Elected to the United States Senate for term ending January 3, 2007, and served from January 3, 2001, to January 17, 2006, when he resigned to become governor of New Jersey. Chair, Democratic Senatorial Campaign Committee (One Hundred Eighth Congress). Governor of New Jersey (2006-2010).
