Biography

A Senator and a Representative from Louisiana. Born in Highland Park, Lake County, Ill. , September 28, 1957. B. S. , Louisiana State University, Baton Rouge, La. , 1979. M. D. , Louisiana State University Medical School, New Orleans, La. , 1983. Physician. Member of the Louisiana state senate, 2006-2008. Elected as a Republican to the One Hundred Eleventh and to the two succeeding Congresses (January 3, 2009-January 3, 2015). Was not a candidate for reelection to the House of Representatives but was elected as a Republican to the United States Senate in 2014 for the term ending January 3, 2021. Reelected in 2020 for the term ending January 3, 2027. Chair, Committee on Health, Education, Labor, and Pensions (One Hundred Nineteenth Congress).
